<u>Decision relating to the determination of Charges in relation to the</u> <u>Airport of Thessaloniki "Makedonia"</u>

Following the notification of the justified proposal for specific changes on the charges of the Airport of Thessaloniki "Makedonia" (SKG), as such were determined pursuant to the decision dated 30th January 2024, and following the consultation session that took place on 10th of December 2024 pursuant to the provisions of the Presidential Decree 52/2012 and

- (a) on the basis of the exchange of views with all involved parties, during the whole consultation process with regards to the changes of airport charges, the needs for readjustment of the charges according to the operational conditions of the Airport and the relevant needs for recovery of cost, as such needs have been presented in the aforementioned consultation session;
- (b) taking into account the letter received by a user dated 19th December 2024 raising its objections against the proposed charges, which we considered and found not to be substantiated for the following reasons:
 - a. Level of existing fees: in addition to the fact that the complaints raised regarding the level of existing fees are vague, the existing fees were discussed during the consultation session on 11th December 2023 following the provision of analytical and reasoned material and an exchange of views with the stakeholders. The decision on the existing fees was published on the Airport website on 30th January 2024.
 - b. Level of detail of the information provided to Users: apart from the vagueness of the complaints raised regarding the information provided to Users, all the material related to the consultations has been provided to Users in accordance with Article 4 of Presidential Decree 52/2012. All objections raised during the consultation session were answered in detail, as can be seen from the relevant minutes and the message of the Airport Managing Body dated 20th December 2024. In any case, the level of analysis of the information provided to Users is sufficient and in line with the requirements of Presidential Decree 52/2012 and EC Directive 2009/12, as it demonstrates the correspondence between the fees imposed and the cost of the services and facilities provided to Users.
 - c. Proposed fee increase from 1st April 2025: the objections raised regarding the proposed increase in certain fees, in addition to being vague, are also unfounded, as the proposed increase to be implemented from 1st April 2025 is within the framework of inflation, is consistent with the provisions of article 28 and Annex 7 of the Concession Agreement, the PD 52/2012 and the EC Directive 2009/12, covers the increased cost of services and facilities provided to Users. In this context, Users will continue to pay only for services and facilities provided to them, while the allocation by category of charge follows the usual practices of the aviation community. The comparison with other European airports is not only vague but also unfounded, as the actual and legal conditions of each airport are substantially different. Moreover, the adjustment of the Passenger Fee from 2nd November 2024 to €15.50, provided that ADF has been imposed, was already provided for in the aforementioned charge determination decision of 30th January 2024 and is not the subject of this

decision.

The changes on the Charges of the Airport that shall enter into force from 1st April 2025 are as follows:
